

CONDITIONS OF PARTICIPATION FOR THE ELECTRICAL ELECTRONICS AND SERVICES EXPORTERS' ASSOCIATION R&D PROJECT BROKERAGE EVENT 2018

1- OBJECTIVES

The objectives of the TET R&D Project Brokerage Event are to allow the Electrical-Electronics and Informatics industry to produce with a high added value; to render exports sustainable; to bring together and ensure a better communication between the representatives of industrial organizations, universities, employees of R&D organizations and techno-parks and researchers in order to enhance university-industry cooperation; to support applications to R&D support programs; and to develop joint project proposals contributing to meet industry's needs.

2- THEMES

The Theme of the Event is Smart Cities. Participants are encouraged to submit project proposals related to the following subthemes, but proposals related to other topics will also be accepted as long as they fall under these main themes.

1. Smart Energy
2. Smart Home and Environment
3. Smart Transportation and Vehicles
4. Smart Health and Medical
5. Other Smart Applications (Consumer Products, Education, Industry etc.)

3- ORGANIZATION

Organized by the Electrical Electronics and Services Exporters' Association (Turkish Electro Technology - TET).

4- CONDITIONS OF PARTICIPATION

- A. Entities (R&D Centers, companies that conduct research, public enterprises (Techno-parks, Tübitak-MAM, Universities etc.)) and individuals focusing on R&D may participate in the event.
- B. The R&D Project Brokerage Event is open to participation of groups. In this case, a participant should be assigned as the group representative.
- C. The projects accepted to the R&D Project Brokerage Event should be represented by at least one person on the date of the Brokerage Event event.

5- PARTICIPATION FORMAT

Applications will be accepted as uploaded files through the Internet.

1. Participants of the Project Brokerage Event, after reading the specifications at www.tetprojepazari.org and confirming the accuracy of the information submitted, will upload project proposal summaries over the website.
2. The posters of the projects accepted into the R&D Project Brokerage Event will be printed by our Association and posted in the fair area before the day of the event.

7- ASSESSMENT OF PROJECTS

The Project Pre-Assessment Committee will assess the conformity of projects to the criteria and send conforming projects to the Project Assessment Committee to be assessed for participation to the event. Applicant projects will be invited to the R&D Project Brokerage Event, based on the assessment results sent by the Project Assessment Committee. Projects not received by the close of business on **July 19th, 2018 until 17:30** will not be assessed.

The projects selected in the pre-assessment will be evaluated by the Project Assessment Community during the event on October 2018.

The members of the Project Assessment Committee will be selected from among the members of the Advisory and Executive Committee based on their areas of expertise.

8- PROJECT ASSESSMENT CRITERIA

The most important criterion for the Project Assessment Committee in selecting projects for display will be conformity to the themes and subthemes. In addition to this, the added value/benefit provided by projects will be considered as another criterion for assessment. Moreover, innovation and applicability of projects will be among the parameters to be considered by the Project Assessment Committee.

9- ASSESSMENT AND AWARD SYSTEM FOR PROJECT COMPETITION

The owners of the projects entitled to participate in the R&D Project Brokerage Event, if they so wish, will be taken into consideration also in the award category. The projects considered most successful by the Award Committee will be awarded the following sums³.

In Each Category

1st Rank: TRY 20,000

2nd Rank: TRY 10,000

3rd Rank: TRY 7,500

The rankings will be awarded on the basis of categories. Projects participating in the award category will be assessed by the Award Committee based on the following criteria: the benefit provided, the innovation introduced, applicability and sustainability.

The members of the Award Committee will be selected by the R&D Project Brokerage Event Executive Committee.

- The Istanbul Metals and Minerals Exporters Association (IMMIB) personnel, members of the assessment committee, substitute members and event reporters (even if they have resigned) and their immediate families are not allowed to participate in the competition. If anything contrary is established, the project in question will be disqualified and, if an award has been granted, the General Secretariat of IMMIB will revoke the award.
- In case works sent to the project Brokerage Event are not original or are claimed to be so, or if third persons claim any rights on them, and in any similar situation, all the responsibility will belong to the project owner. Participating projects are expected not to have been presented previously in any other project Brokerage Event.
- TET has the right to cancel the event without any reason.
